

Unitarian Universalist Fellowship of Chico Board Meeting

January 13, 2022

1. The Board gathered beginning at 7:01 pm. Dave informed the group that the UUA survey was to get feedback on the activities UUFC was doing. He also thought it gave the congregation an idea of what other UUs are doing. The Board meeting began at 7:15 and Dave K. gave opening words.
2. Ed Mayer, Butte County Housing Director, was invited by Bob earlier this past fall, then joined our January meeting talking with us on the broader historical overview of local and county housing policy, current challenges in Butte County and Chico and even some thoughts on how we might consider the potential opportunity of our church property being used for some type of low-income housing. It was an interesting and enlightening perspective that we could consider and use for more in-depth conversation within our Fellowship in the future.
3. It was discovered that Merrily Stover is the only authorized signature on the Articles of Incorporation. The Board will need to determine who else should be authorized.

Masks will be required when indoors. If someone gets COVID, they should contact Pam who will contact everyone who signs the attendance sheet that Sunday.**

The request to have choir without a choir director will be discussed next month.

- D. February Caring Committee Event** – The Caring Committee is planning an outdoor event after services on February 13 but haven't decided what the event will be.
